- (1) When gathering service is performed into the origin points contained herein, the total through rate to destination will be made by adding the pipeline gathering rate to the pipeline transportation rate.
- (2) **Truck Unloading:** Where trucks are unloaded on Carrier’s main line at any of the origins identified above, a special handling charge of [I] 33.60 cents per barrel will be added to the trunk line rate in effect.
- (3) **Power and Flow Improver Surcharge:** Carrier will assess a power and flow improver surcharge of [I] 23.46 cents per barrel applicable to all volumes delivered into Granger Station or injected into the SLC Core Pipeline system between Granger Station and Wahsatch Station.
